CITY OF RAINBOW CITY-COUNCIL MEETING-NOVEMBER 9 , 2020

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m., and upon roll call by City Clerk, Beth Lee, the following members answered present: Mayor Joe Taylor, Randy Vice, Jeff Prince, Jameson Jenkins, and Clark Hopper. The same constituting a quorum of the City Council, the following business was transacted. The meeting was called to order by Mayor Taylor. Invocation was given by Randy Vice. Mayor Taylor led the Pledge of Allegiance to the flag.

1. Mayor Taylor presented the minutes of regular Council meeting of October 26, 2020 and special (Organizational) meeting of November 2, 2020 and asked if there were any corrections, additions, or deletions. There being none, Jameson Jenkins made a motion to approve the minutes as presented. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
2. Mayor Taylor stated that a member from the Council needed to be appointed to the Planning Commission. Clark Hopper made a motion to table. Jeff Prince seconded the motion. Mayor Taylor asked for a roll call as follows:

Mayor Taylor declared the motion carried.

3. Mayor Taylor stated that credit cards be issued from Exchange Bank to the following: Joe Taylor, Randy Vice, Jeff Prince, Jameson Jenkins, and Clark Hopper. These credit cards are to be used for educational registration and travel. Randy Vice made a motion to have the credit cards issued from Exchange Bank. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
4. Mayor Taylor stated that former Mayor Calhoun needed to be deleted from all EXBA and BBVA accounts and add himself to these accounts. Beth Lee, City Clerk and Crystal Gazaway, Accounting Clerk are also on these accounts. Jameson Jenkins made a motion to delete former Mayor Calhoun and add Mayor Taylor to these accounts. Randy Vice seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
5. Mayor Taylor stated that sealed bids were opened in Pre-Council for animal cages for Animal Control. One bid was received as follows:

8. Mayor Taylor presented the monthly departmental reports from Animal Control, Building, Community Center, Court, Fire, Library, and Police. Jeff Prince made a motion to accept the reports as presented. Clark Hopper seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
