## CITY OF RAINBOW CITY-COUNCIL MEETING-FEBRUARY 8, 2021

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Anita Bedwell. Mayor Taylor led the Pledge of Allegiance to the flag. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Jameson Jenkins, Clark Hopper and Mayor Taylor. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of regular Council meeting of January 25, 2021 and asked if there were any corrections, additions, or deletions. There being none, Jeff Prince made a motion to approve the minutes as presented. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 2. Mayor Taylor presented the resignation of Recreation Dept. employee Dalton Hannah. His last day will be Thursday, February 11, 2021. Anita Bedwell made a motion to accept the resignation. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 3. Randy Vice made a motion to post three (3) laborer positions in the Recreation Dept. for ten (10) days to end on Friday, February 19, 2021. Anita Bedwell seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 4. Mayor Taylor made a recommendation to hire Sydney Griffith as part-time in the Animal Control at \$11.25/hr. Her start date was January 29, 2021. Jameson Jenkins made a motion to approve hiring Sydney Griffith. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

Clark Hopper made a motion to approve these Street Dept. changes. Randy Vice seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

- 8. Mayor Taylor had a recommendation from Chief McKee to rescind the Promotional Procedures for the Fire Dept. adopted on April 23, 2018 Item #2. Jameson Jenkins made a motion to rescind these Promotion Procedures. Clark Hopper seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 9. Mayor Taylor made the recommendation to hire Luke Palacios as firefighter/EMT at \$14.00/hr. with family coverage insurance to start Friday, February 26, 2021. Jameson Jenkins made the motion to hire Luke Palacios. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 10. Mayor Taylor presented the following promotions in the Fire Dept. effective Friday, February 12, 2021 as follows:

Anita Bedwell made a motion to surplus the 2008 Ford Taurus (Administration) VIN# 9467 and to accept sealed bids to be turned in to the City Clerk's office by 4:00 p.m. on Friday, February 19, 2021. There will be a \$1,200.00 reserve. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 12. Mayor Taylor stated that no action will be taken at this time on EARPDC preparing a Recreational Trails Program grant for Rainbow City.
- 13. Mayor Taylor presented Resolution No. 21-01 Extend the Emergency Paid Sick Leave for Employee Quarantine and/or Positive COVID-19 Test to end on March 31, 2021. Jeff Prince made a motion to approve Resolution No. 21-01. Randy Vice seconded the motion. Mayor Taylor asked for a roll call as follows:
