CITY OF RAINBOW CITY-COUNCIL MEETING-MARCH 22, 2021

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Clark Hopper. Mayor Taylor led the Pledge of Allegiance to the flag. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Clark Hopper and Mayor Taylor. Jameson Jenkins-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- 1. Mayor Taylor presented the minutes of regular Council meeting of March 8, 2021 and special called council meeting of March 12, 2021 and asked if there were any corrections, additions, or deletions. There being none, Clark Hopper made a motion to approve the minutes as presented. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 2. Mayor Taylor presented Proclamation No. 21-03 Pat Patterson Day and being the first member in the Rainbow City Centenarian Club. He was joined by his daughter, Leslie McGlaughn and many family members.
- 3. Mayor Taylor presented a request to purchase a 2021 Ford F250 Super Cab 4x4 for the Recreation Dept. from the state bid list base price of \$28,769.00 with the added option to Crew Cab 4x4 for a total of \$32,103.00 from Stivers Ford.  - Purchase four (4) 2021 Chevrolet Tahoe 2WD 4dr Commercial for a base price of \$33,563.00/ea. with option of \$1,417.26 for a total of \$34,980.26/ea.
 \$50,000.00 will be paid from the Court Fund and the remaining balance will be a note payable to Exchange Bank.

Randy Vice made a motion to approve these purchases. Anita Bedwell seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

- **5.** Mayor Taylor presented the following changes in the Police Dept. personnel as follows:

 - Hire Jakob Hunter as a Certified Police Officer at \$14.50/hr. with family coverage insurance. Start date is Friday, April 9, 2021
