CITY OF RAINBOW CITY-COUNCIL MEETING-MAY 10, 2021

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Randy Vice. Mayor Taylor led the Pledge of Allegiance to the flag. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Randy Vice, Jeff Prince, Jameson Jenkins, Clark Hopper and Mayor Taylor. Anita Bedwell-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- 1. Mayor Taylor presented the minutes of regular Council meeting of April 26, 2021 and asked if there were any corrections, additions, or deletions. There being none, Randy Vice made a motion to approve the minutes as presented. Clark Hopper seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 2. Mayor Taylor presented a quote from Vulcan Materials Company to tar and gravel Lindsey Street for \$48,450.00. This will make for a better base, longer life, and save money on leveling. Clark Hopper moved and Jameson Jenkins seconded the motion to hire Skylar Trainor. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 5. Mayor Taylor presented Resolution No. 21-06 Pledge to the Alabama Federation for Advanced Manufacturing Education (FAME) at Gadsden State Community College. Rainbow City is pledging \$2,500.00 per year for 5 years as this training program helps students become highly skilled and globally competitive in the advanced manufacturing workforce. The Rainbow City workforce would benefit from this program by hiring these students as there are approximately 150-250 industrial jobs in our City. Jeff Prince made a motion to adopt this resolution. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 6. Mayor Taylor presented a budget revision <u>Police Dept.</u> Increase is from the Police cash drawer.
