1. A quorum was declared so the meeting proceeded as follows:
2. The minutes from September 8, 2016 meeting were read. Tim Ramsey moved to approve the minutes as read. Jerry Weaver seconded the motion. All ayes. Chairman called motion carried.

5. The name of the park was discussed. The Board members present all agreed that "Rainbow City" should be a part of the name of the industrial park.
6. Discussion then began on whether the Board is an Industrial Development Board or an Economic Development Board. Dana Rice stated that he had researched this when he was asked to be the attorney for the City on this Board. He wants to do a little more research and get back with the committee next month. At some point in time there may need to be another board or add to this board and work for both industrial and economic growth.
